MOTION FOR LEAVE TO FILE via CM / ECF

Plaintiffs, Gordon Wayne Watts, et. al., by and through undersigned counsel, and pursuant to **Middle District Local Rule 3.01(a)**, hereby move This Honourable Court for leave to be allowed to register for CM/ECF (Case Management/Electronic Case Filing), and file any subsequent pleadings and exhibits – and in support thereof, state as follows:

1. This court's website states that: “Absent a judge's permission, CM/ECF is unavailable to non-lawyers.” Cite: <https://www.flmd.uscourts.gov/cmecf>

2. Some of the filings in the state courts in question are too lengthy to “be good” for a poor litigant to print up on a cheap computer printer—not to mention mailing costs. As we are in the electronic age, filing electronically is more efficient.

3. While there are no “hard limits” on what number of documents can be filed, Lead Plaintiff, Watts, wishes to only file a small number of additional filings, such as the original Intervention motion, giving rise to this complaint, and one very helpful *Amicus* filing



PRO: However, finding the 'right' brief on said docket, while entirely possible (and even quite easy for lawyers and judges) is not unlike finding a "needle in a haystack," and thus possibly less efficient than simply having the 'right' docs on file in this complaint.

Wherefore, Plaintiffs respectfully request This Honourable Court to enter an order granting plaintiffs leave to be allowed to register for CM/ECF and file the small number of exhibits necessary to allow This Court to see the filings which document numerous "denial of due process" acts committed by state actors, acting under "The Colour of Law."


