#### **My question to Dennis is this:**

Why did he appear to flip-flop on this issue (first opposing BK protections in his email, and then supporting them, which seems fair, since other borrowers have this option)? – Only 4 possible explanations exist, and I can eliminate one of them:

- 1) He could have “flip-flopped” to pander to the current opinion, but I eliminate this option, as Dennis and his current staff pass the Integrity test with 100% - going above and beyond what is required.
- 2) Dennis could have had a genuine “flip-flop” based on a change of mind, new information, etc.
- 3) Dennis is a very busy man, and it is possible that he was under pressure (he was new to office, and had not set up his staff completely), and thus maybe did not think things through.
- 4) Lastly, it is also possible that a staff member was answering emails in his name, and somehow a miscommunication occurred and/or the staffer “guessed” wrongly.

My guess would be that #4 is the most likely possibility, and this is based on the fact that Katie Hughes and I collectively agreed that this is probably what happened in the 'Heavy Hand' Facebook/Twittergate blocking scandal: We think that, probably, an overzealous staffer (who is no longer with Ross' office) got carried away...but, I don't know for sure. – It looked like a 'flip-flop,' but it can't be: Dennis is a man of integrity... Only Dennis would know why he gave 2 apparently different answers... Thank you to both you, Katie, Dennis, and his staffers for all y'all's collective assistance on this -and other matters... That was my only question, but, after hearing Sen. Rubio, I have some helpful feedback on Immigration. Please see the next page...

I did get Dennis' postal letter to me, dated July 09, 2014, in which he informs me of his co-sponsorship of H.R. 4962, the Nat'l Border & Homeland Sec. Act, which would add Border Patrol agents and fund the Border Fence, while mandating/ordering that it be built.

Re: "Ross: Spending Cuts Needed to Reduce Deficit," Jan. 2. Your article begins with this paraphrase: "Rep. Dennis Ross would have voted against legislation to stop from going over the fiscal cliff even if it meant going over it."

Although I agree with his fiscal-cliff no vote, this time, here is a canard: Because he voted yes on four of six pork-laden appropriation bills in his tenure, Ross is not conservative. Appropriation bills are huge and dwarf all other spending.

However, when I tried to express my views on this and other political matters on his Facebook page, he deleted all my comments and blocked me from posting.

Were this his personal Facebook page or Twitter feed, this would be immoral, but not illegal. However, so long as I don't threaten, harass or use vulgar language, I have a right to post on his public page, distinct from a private or personal page. He's violating free-speech rights and, by extension, First Amendment rights of redress.

Most readers know that, while I have strong opinions, I've never gotten banned from The Ledger's forums, so I'm clearly not a troublemaker.

Furthermore, if it were "just Gordon" complaining, you might give Ross the benefit of the doubt.

However, many people are making complaints that Ross unjustly blocked them from these social networks.

If Ross is not justified in this, then why is he doing it? To silence those who disagree with legislative requests of rich campaign contributors?

**Dear friends at The Tampa Tribune, The Ledger, and elsewhere --**

You recall my email this past Nov. 30, I'm sure, where I told you that my U.S. Congressman, Dennis A. Ross (R-Fla-12th) was acting **\*\*very\*\*** bizarre and blocking a **\*\*whole\*\*** bunch of people from his Twitter, Facebook, and basically most/all of his social media. **1) >> Congressman Ross, when confronted by a large, angry crowd, admitted that he blocked/banned a bunch of "postal employees" from his public Facebook page** (not to be confused with his personal Facebook) allegedly "for abusive, vulgar, or personal attacks...because their posts and messages were abusive or bordering on the slanderous."

For Rep. Ross, who claims to be 'Conservative,' it is embarrassing to have people like Uphagrove (a liberal Democrat) saying Ross and his party are too liberal in how they over-spend. Notice that there is no dialogue box to enter your comment, or 'comment' link.

(Note: The THM was actually on Thr. Apr. 04, 2013, as shown by the bottom half of this screenshot, but the top half, which has a Facebook post, apparently was posted the next day. Also, as stated in the inception of this blog entry, there was a major update: Ross' staff unblocked me, and later, unblocked Uphagrove, who we think were blocked by an over-zealous staff member no longer with Ross' office. So, Ross and his staff deserve credit here for unblocking us -and for allowing us to post unfettered on his Facebook fan page. In short, Ross' staff's unblocking of me was a genuine, honest action, not a 'reaction' to news media pressure, which had not manifested until about 12 hours \*after\* their action. END OF UPDATE --G.W.)
