Landon, as the House votes to end the shutdown today, Rep. Lee has a **narrow**** 14-day window to lead on DHS reform. Here are the three tools she needs:"**

1. **The Evidence:** A citizen video ("Angle 2" -- see below) proving a DHS agent disarmed Alex Pretti before the shooting. This contradicts the current DHS narrative.
2. **The Abuse:** The "Don Lemon" arrest—a DOJ/DHS bypass of three federal judges who had already rejected the charges.
3. **The Fix:** The **Middleman Elimination Act (MEA)**. Use the DHS funding negotiations to strip the budget for the "administrative middlemen" who are currently hiding this footage and shopping for grand juries.

Redux:

1-2. The Oversight Evidence (The "Pretti-Lemon" Pattern): Enclosed is a forensic breakdown of the Alex Pretti shooting in Minneapolis. Our "Angle 2" analysis proves a federal agent in a grey jacket disarmed the suspect *prior* to the fatal shots—a fact currently missing from the DHS preliminary report to Congress (Jan 28). Simultaneously, the DOJ's "Grand Jury bypass" in the Don Lemon arrest—occurring only after **Chief Judge Patrick Schiltz** and two other judges rejected the warrants—shows an executive branch operating in open defiance of the judiciary.

3. The Legislative Solution (Middleman Elimination Act): These abuses are only possible because of the bloated "Administrative Middlemen" within DHS and DOJ who filter evidence and bypass court orders. To address this, I am proposing an expansion of the **Middleman Elimination Act (MEA)** principles currently being applied to healthcare insurance middlemen and the "College Loan" Middleman in this MEA proposal.

By eliminating the redundant "oversight" layers that actually serve as "opacity layers," we can ensure that:

- Federal agents are directly accountable to the courts (No "Grey Jacket" evidence hiding).
- The DOJ cannot "shop" for Grand Juries to override specific judicial rejections

The Request: I am requesting a brief meeting to share the "Angle 2" video evidence *and* discuss how the MEA (Middleman Elimination Act) can be used as a legislative "Sledgehammer" to restore constitutional order to all four (4) agencies:

i.) DOJ (Dept of Justice)

ii.) DHS (Dept of Homeland Security)

Below is the final draft of what I plan to send you from my professional (work) email address, Gordon@contractwithamerica2.com aka Contract With America: Part II (®), a continuation of Newt Gingrich's Part I, BUT NOT AFFILIATED with Gingrich, and seeking bipartisan legislation, not election of Republicans as his version did.

documenting that immediately after our promises of bad news coverage from Conservative Press, for Hawley not keeping his word, he didn't respond to us AT ALL, but IMMEDIATELY jumped on as a cosponsor for S.2598, 117th, and because THE REGISTER, my paper, pushed him to do this, his bill -- like H.R.5899, 116th, ended up with 2 GOP sponsors and 1 Democrat sponsor, making these two student loan bankruptcy bills safe for Lee to refile in the CR tomorrow: They both had more Republican sponsors than Democrat.

Please excuse my last email -- autocorrect messed up your email address, casing a typo, and "returned mail," thus I'm resending.

This addresses both the MINNISOTA / ICE matter (thus, besides lawmakers, I'm cc copying HCSA and local Minnesota press), and some economic problems that that are time-sensitive: The CR expires this Friday, 28 January 2026. My Minnesota email contacts probably wonder why I include them in my email about economic matters? Well, if Trump / Republicans / Democrats can address "affordability" and "spending" concerns shared by Conservatives (spending) and Liberals (affordability), then "stress" in Minnesota will go DOWN and peace between ICE / Gov. Tim Waltz / Protestors / Trump will go UP, ok?

Again, thanks to Rep. Lee for working on good bipartisan legislation with Democrats Rep. Alexandria Ocasio-Cortez (recent AI deepfake bill) and Rep.
