**Re: GMAC Mortgage, LLC v. Watts, Gordon Wayne, No: 1-18-0091 (Appellate Court of Illinois, First District)****Court and Counsel:**

I have just filed my Docketing Statement and Appearance in the above-captioned case; it's attached as a PDF file. Also, while it's probably very boring reading, I'm required by court rules to serve you a copy of my Fee Waiver Application in the appellate court (take a look at the approved form attached to this email to verify this requirement). While the trial court's waiver app doesn't make this same requirement, I'm attaching it just in case some legal wonk wants to ask the IL Supreme Court to change the appellate form rules to allow Fee Waiver applications to be sent *ex parte*, e.g., solely to the court, like the trial court app, here. See also the receipts from my eFiling to verify it was filed with the court.

My apologies for sending you a 2nd copy of my Docketing Statement (which I previously served you with my Notice of Appeal), **but the reviewing court asked me to resend it once I got a case number**; it's attached, as I'm required to do. Also, I updated my Docketing Statement with new proposed arguments (not in my prior Docketing Statement that I sent you earlier), now that I got a "redo." I addressed some overlooked legal points, chiefly an older 2013 order by Judge Michael F. Otto, in which he admits massive fraud, thereby helping my argument, an order dated March 08, 2013, in which he basically admitted fraud; Otto's order & my analysis, is a good read, in my opinion.
